


# Purpose of Vision & Guiding Principles

  - Summarize unique challenges and opportunities Petaluma faces






# **Workshop Objectives**

- Review and confirm the "areas of discussion"




# **Workshop Approach**



#### Levels of Change Scale

- 1 = <u>Maintain</u> as is with minor improvements for livability, safety, and quality of life.
- 3 = Some redevelopment with the overall outcome a mix of existing development and new uses and/or higher densities.
- 5 = <u>Transform</u> area over time so that it looks, feels, and functions very differently from its current character. This includes significant new development including higher densities and new/different uses.




#### Introduction

This document summarizes the preliminary draft "Pillars of Petaluma" (or values) and Guiding Principles for the General Plan. These are for preliminary review and input by the GPAC.

The Pillars of Petaluma are the broad values on which the General Plan will be constructed. These were developed based on the General Plan Team's interpretation of comments and ideas provided by the GPAC and the community thus far in the update process. The Pillars can be thought of as cross-cutting values that permeate the entire update process and, ultimately, the content in the General Plan

The Guiding Principles are more specific "directions" for the General Plan. The existing General Plan has 15 Guiding Principles. As is stated in the document, the purpose of the Guiding Principles is to "provide the basis for the goals, policies, and programs in the Plan elements." The Guiding Principles were reviewed by the GPAC on August 19, 2021. The General Plan Team used this feedback, along with broad community input from the four Area Meetings, which occurred during the last 2 weeks of August, to craft the proposed draft Guiding Principles below.


